Tomahawk Mill Contractor Safety Video

This orientation provides a description of practices and policies that our contractors are expected to follow and is required every year. Questions should be directed to either the Contractor Personnel Guide or your PCA Contractor Representative. In order to minimize congestion on site we suggest that you watch this video at your convenience before arriving to our site. Parking

The contractor parking area is the only place that contractor personal vehicles may be parked.

Utility vehicles may be allowed to park vehicles inside of the mill gates if determined necessary by your project manager. If deemed necessary a parking pass will be given to the vehicle driver upon entry.

Any other vehicle use in the mill will be on a temporary basis only and are expected to load/unload and be removed as soon as possible; temporary vehicle passes are available from security.



Vehicle Use

In the contractor orientation video several areas around the facility have been identified as hazardous and require acknowledgement from PCA operators before entering. These areas include the chip slab, warehouses, and the alley between the waste warehouse and PM4 building. If these areas need to be accessed please contact security and they will inform the appropriate PCA personnel.

FR Clothing

All employees, visitors, and contractors entering the Power, Recovery, and Semi-Chem Areas are required to wear a flame retardant jacket or an equivalent as well as cotton denim pants when in these areas.

High Visibility

High visibility clothing is required for all jobs taking place outdoors, when traversing the mill north of the Power house area, and anytime that someone enters any of the shipping or waste receiving docks.

Cell Phone Use

Cell phone use is allowed in the mill, however due to the large volume of traffic (pedestrian and vehicle) in the mill, contracted employees shall not use a mobile device when performing a safety sensitive function, i.e. Fire Watch, Confined Space Attendant, Operating equipment.

Every person at the Tomahawk Mill is expected to be alert at all times when traversing the facility, traversing the facility while attending to your personal devices hinders attention to surroundings and must be avoided.

Tobacco Free

As of February 1, 2017 the Tomahawk Mill will be a tobacco free workplace, conformance with this policy is mandatory.
